4. First Aid

Exposure

Swallowed

IF SWALLOWED: Call a POISON CENTRE or doctor/physician if you feel unwell. Rinse mouth. Do NOT induce vomiting. Give a glass of water to drink.

Eye contact

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

Skin contact

IF ON SKIN: Wash with plenty of soap and water. If skin irritation occurs: Get medical advice/ attention. Take off contaminated clothing and wash before re-use.

Inhaled

Generally, inhalation of dusts is unlikely to result in adverse health effects. If coughing, dizziness or shortness of breath is experienced, remove the patient to fresh air immediately. If patient is unconscious, place in the recovery position (on the side) for transport and contact a doctor.

Suitable extinguishing substances:

Carbon dioxide, extinguishing powder or water jet. Fight larger fires with water jet or alcohol resistant foam.

Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Water. May form toxic mixtures in air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures.

6. Accidental Release Measures

Containment

If greater than 10000kg is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.

Emergency procedures

If a significant spill occurs:

Stop leak if safe/necessary; Isolate area. Collect spill – see below; Transfer to container for disposal. Dispose of according to guidelines below (Section 13).

Clean-up method

Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

Disposal

Mop up and collect recoverable material into labelled containers for recycling or salvage. Recycle containers wherever possible. This material may be suitable for approved landfill. Dispose of only in accord with all regulations.

Precautions

No special protective clothing is normally necessary.



7. Storage & Handling

Engineering Controls

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. Exposure can be reduced by process modification, use of local exhaust ventilation, capturing substances at the source, or other methods. Skin	If discomfort is felt (e.g., if pre-existing conditions exist, such as dermatitis, cuts or sensitive skin), gloves may be helpful. If you suffer from dermatitis type skin conditions, use gloves. Respiratory	A respirator when airborne concentrations approach the WES (section 8). Respirators must have filters appropriate to the duty and comply with AS/NZS1716 and selected, used and maintained in accordance with AS/NS 1715. Use a respirator with a particulate filter. If using a respirator, ensure that the cartridges are correct for the potential air contamination and are in good working order. Fit testing and clear guidelines and training for use and maintenance of PPE are necessary.
